Dear Beckley Area Foundation Community,

As BAF celebrates the first anniversary of our new permanent location on South Kanawha Street we have not lost sight of the support and generous contributions provided during the past year to make this happen now debt free. One person at a time, one donation at a time helped BAF achieve this financial goal.

BAF's theme for the current year is "Donors making a Difference". The impact of this Foundation during the 2023 fiscal year includes distributions of over \$475,000 to 64 organizations through the donor designated endowed funds, scholarship awards exceeding \$450,000 to over 200 applicants, while the Community Grant program awarded over \$175,000 to more than 40 non-profit groups. BAF remains one of the largest contributors addressing the unmet needs of our community by collaborating and assisting to enhance the well-being of so many. None of this would be possible without the support and commitment of our donors.

During the past year market conditions challenged our local trust departments charged with the fiduciary responsibility to manage the Foundation's endowed funds. Foundation assets accumulated over the past 38 years from over 500 funds now exceed \$60,000,000 and provided cumulative grant distributions of over \$21,000,000. We remain focused in our efforts to monitor and protect your investment in the Foundation. We thank you and remain excited for what the future holds for our community.

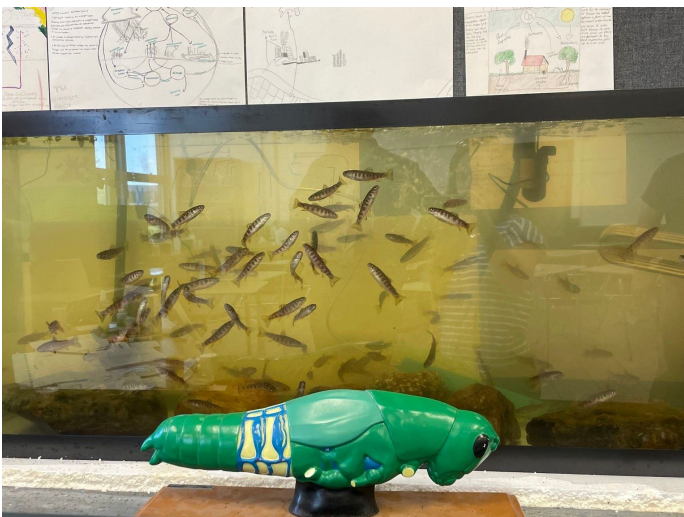

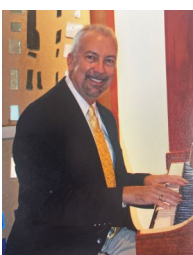

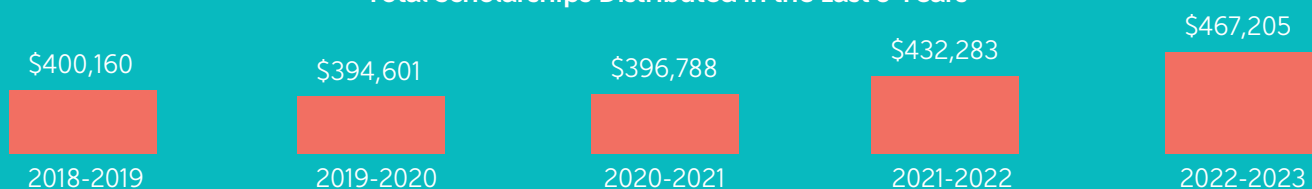

"Reading has long been a fundamental love and part of both of our lives for as long as we can remember. We were fortunate to have been exposed to reading and encouraged to read as much as we could at an early age.

It is how, as the poet Jack Prelutsky put it, "we met a dragon face to face, took a trip to outer space, braved a pirate's den, wrestled a troll, followed the rabbit down a hole, opened magic doors, travelled through time, and searched for dinosaurs, among other things, all by the time we were ten."

Reading opens and expands our minds into things we can then dream of; or turn our thoughts into reality. Written words have enchanted and defined us for thousands of years, given us authors about whom we still read & talk about centuries later or yesterday. They have defined cultures & civilizations." – Mark & Teresa Neil

Native West Virginians, Mark & Teresa have long called Beckley their home. Although they now reside along a tributary of the Chesapeake Bay in Virginia enjoying retirement, they wanted to find a way to support important parts of public education in Raleigh County through school-based initiatives. Their many years of association with various civic organizations & programs, along with familiarity of BAF, made it their choice to administer the fund.

"It is our hope that by supporting reading programs for our children that they, too, will find the magic and wonderment of written words which open the doors of a lifetime of knowledge & entertainment. In doing so, we hope they will learn that no matter how many books have been written over time, there are more crafted every day. Perhaps by being exposed to reading early in their life, they may be the ones to write more of them.

If you have ever participated in the creation or presentation of the performing arts, or as a bystander enjoying the presentations of these arts, then you will understand what an impact they have on our lives. It is our hope that by exposing young people to these forms of expression they may find that they can become more than the sum of their total and express themselves in different manners and venues that transcend mere words, to grow beyond themselves and reach a higher plain. 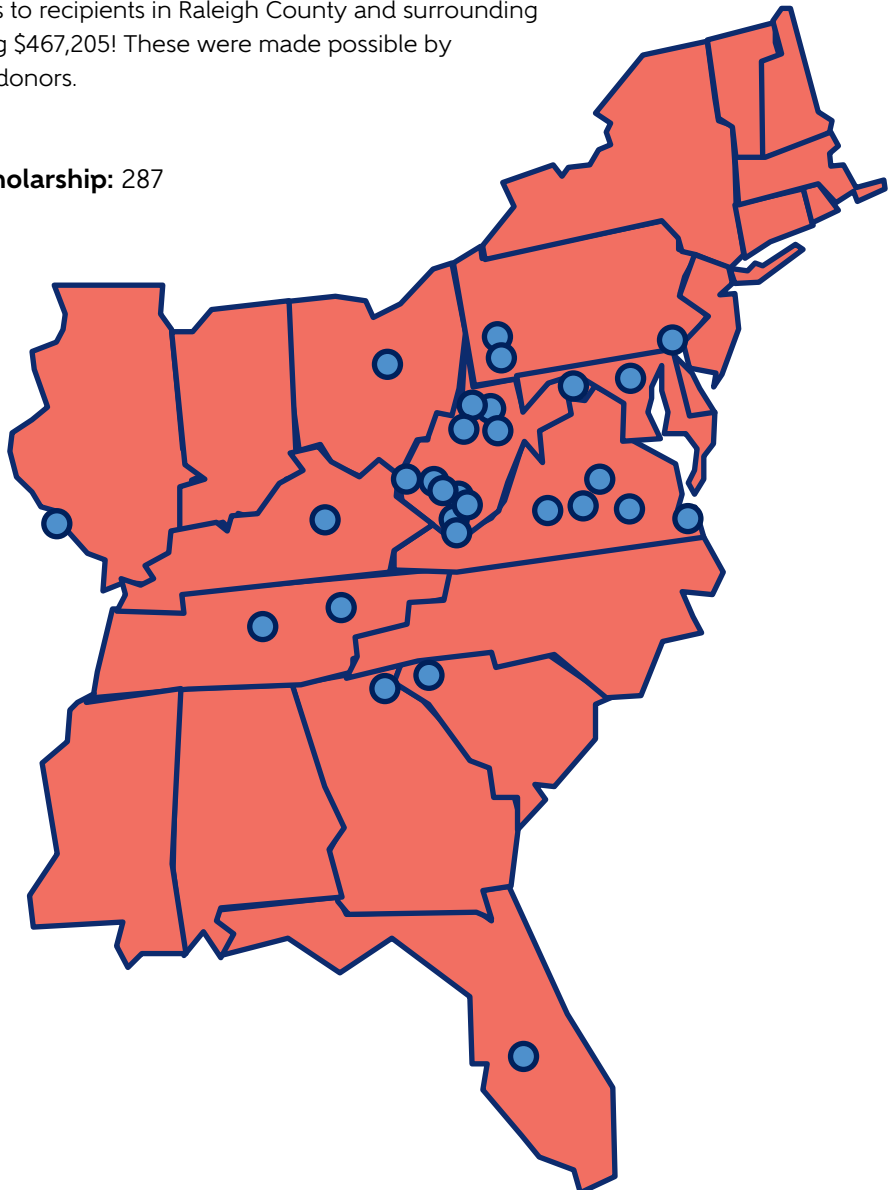

Students First Program

Starting in 1996, BAF designed the Students First Program to provide funding support for creative and innovative instructional projects in Raleigh County. Since inception, over \$365,000 has been awarded to K-12th grade classrooms. Last year, BAF awarded 42 local educators mini-grants up to \$500 each. Over \$19,000 was distributed to 25 schools for 48 innovative projects to be completed during the 2022-2023 school year.

Restaurant Day – Bradley Elementary School



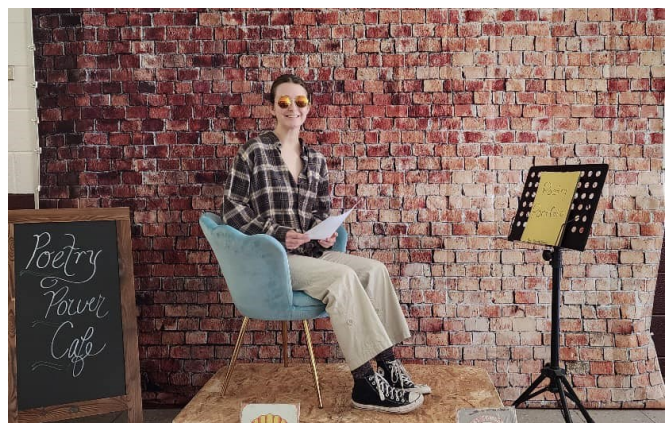

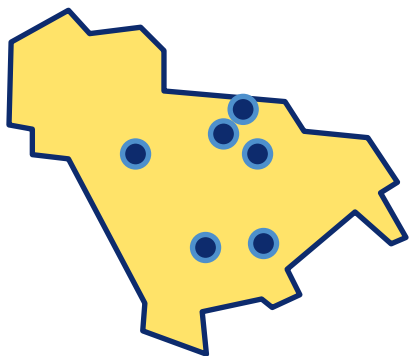

On Saturday, March 25th, SLYP hosted the Hip Hop Hooray 5K at WWHS with support from community sponsors. The Easter themed run/walk took place on an all-pavement course for adult runners & included a fun run for kids.

The Hip Hop Hooray 5K raised \$4,000 for the Raleigh County community, which allowed the Junior Cohort to use these funds to review grant applications & award money to nonprofit organizations in our community. Over 40 people registered for the event and the 5K had 13 sponsors supporting the cause.

In spring 2023, the Junior Cohort held a strategic exercise to identify what type of local projects they would like to focus their grantmaking dollars on. It was decided to focus on youth in our community, to help other students in situations outside their control. Applications were accepted and then site visits were done at each location, as an added educational experience for the students and nonprofits.

SLYP awarded 5 grants to Raleigh County nonprofits, totaling \$4,500, and were presented at the 2023 SLYP Capstone Ceremony on May 8th, at Faith Community Church.

Community Grant Program

BAF makes annual discretionary grants to charitable organizations serving Raleigh County in the areas of animal services, the arts, civic beautification, education, health & human services and public recreation. Using the pooled income from unrestricted funds, BAF addresses the community's most pressing needs and promising opportunities.

A distribution committee comprised of community volunteers review all proposals and makes recommendations to the Board of Directors, who make the final decision on all grants. BAF Board of Directors approved \$177,875 to fund 39 projects between April 2022 and March 2023.

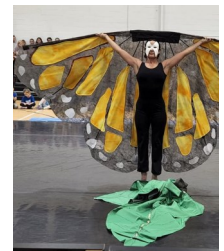

Leave a Legacy

Leave a Legacy is a way for individuals to leave a charitable bequest to the organizations they value most. All types of nonprofit groups, including social service and arts organizations, churches, hospitals and educational institutions can benefit from charitable bequests.

Leaving a bequest can have a significant impact over time and make a difference to an organization or your local community. Some people think they must choose between leaving a gift to their family or their favorite nonprofit organization. You can do both, and some charitable gifts may save your family money by decreasing inheritance taxes! A simple gift provision in your will can make a difference in many lives for years to come.

Here are some important things to remember when you think about leaving a bequest:

- Make sure you have an updated will (or living trust) that reflects your charitable objectives. Without these documents, you surrender control of your property and assets to the courts.
- Contact your financial advisor (a financial planner, lawyer, or accountant) and ask for help in establishing a charitable gift.
- Think beyond cash – you can leave stocks, real estate, insurance policies, and private property to charitable organizations.
- Make a local nonprofit organization a beneficiary of your life insurance, pension plan or IRA.



Robert Kosnoski

Robert Kosnoski was a very successful business entrepreneur. He developed and owned companies in the mining industry & supported operations in industrial equipment repair as well as land reclamation and stone quarries. He was a leader in the surface mining industry for more than twenty years. He was President and Vice President of numerous mining companies, and he also owned & operated many construction companies in the Beckley area. Mr. Kosnoski founded the Crossroads National Bank in Beckley & was Chairman of the Board for several years.

Robert was committed to education and generously supported the College of WV as well as BAF. He supported many local charitable entities. He was the first person to receive his license from the Beckley Flying School, Beckley-Mount Hope Airport. He loved spending time working on his farm on Sweeneysburg Road. He was a 1953 graduate of Woodrow Wilson High School and always supported their class reunion events. He was accomplished at all of his endeavors.

In 2001, Mr. Kosnoski established the Robert L. Kosnoski Scholarship Fund which provides scholarships to WWHS graduates to any accredited institution of high learning. Upon his death in 2017, BAF received a generous bequest to further enhance opportunities for students.



Richard A. Rice

Richard "Rick" A. Rice, Jr., was born in 1954, to Richard "Buddy" and Virginia "Ginny" Rice. He lived in Beckley, WV, his entire life and graduated from Woodrow Wilson High School before obtaining his B.S. in Education. Due to his entrepreneurial spirit and drive, he became an owner of the Gallagher Coal Research Center located in Crab Orchard, WV, where he served the coal industry for decades through his expertise in coal testing. Rick was a long time member of the Oak Grove Christian Church. He enjoyed spending time at his river camp in Forest Hill on the Greenbrier River, feeding corn to the deer and watching the river go by. He was also a talented wood worker/furniture maker and enjoyed collecting classic cars.

Richard established the Richard A. Rice Fund in 2015 which supports the Raleigh County Humane Society. Upon his death in December 2020, BAF received a sizeable bequest that will continue to support the Humane Society in perpetuity.

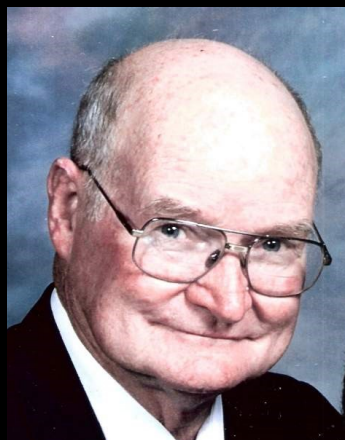
